The words "we," "us," and "our" refer to Farm Credit of Central Florida, ACA, with whom you have your account, and the words "you" and "your" mean you, the individual borrower(s) or member(s) or entity identified on the account(s). "Communication" means any agreements or amendments thereto, disclosures, notices, transaction history, privacy policies and all other information related to the product or service, including but not limited to information that we are required by law to provide to you in writing.

When you use a product or service to which this disclosure applies, you agree that we may provide you with any communications in electronic format, and that we may discontinue sending paper communications to you, unless and until you withdraw your consent as described below. Your consent to receive electronic communications and transactions includes, but is not limited to:

- · All legal and regulatory disclosures and communications associated with the product or service for your account(s)
- Notices or disclosures about a change in the terms of your account or associated payment feature and responses to claims
- Privacy policies
- If you are a member of the association, your initial welcome package, annual and quarterly reports, annual meeting information statements, reports of condition of the Federal Agricultural Mortgage Corporation (Farmer Mac), and notices of significant changes in a Farm Credit System institution's permanent capital ratio
